For an exam, it will likely be from the exam invigilator reports or can be picked up by the Marker.

For coursework, it will likely be picked up from the Marker and Module Leader. All work will be run through Turnitin detector software to determine originality, and it can check for plagiarism/collusion and use of AI.

It may be that the University could be alerted to a possible academic misconduct offence by a third party, such as essay mill companies, which would trigger an investigation into the work. There may be discrepancies in the work that the Marker/Module Leader notices, such as references or language; they may then pass this over to an Academic Integrity Coordinator to begin an investigation.

If you wish to request a review, please set out in writing your reasons and send it within 2 months of the date of this letter to the Group Chief People and Legal Officer, London South Bank University, 103 Borough Road, London, SE1 0AA. We will aim to carry out the review within 20 working days, or in exceptional circumstances within 40 working days.
