Level 6

Levy Funded

Job role

The occupation covered by this standard is that of Construction Site Manager. Typical job titles can include: Construction Site Manager, Assistant Construction Site Manager, Site Manager, Sub Agent, Assistant Site Manager or Construction Planner. They are associated with the management of building construction projects and are based on sites or in offices. There are two pathways associated with this occupation: Assistant Construction Site Manager and Assistant Construction Planner.

Duration

3-4yrs including end point assessment.

Academic award

Construction Management BSc (Hons).

Programme description

The academic component of this apprenticeship standard will include the following modules:

- Construction Contract Law
- Production Management
- Measurement 1 & Documentation
- Management of Organisation

- Contract Administration
- Estimating & Tendering Process
- Project Management
- Construction Planning
- Sustainable Construction & the Environment
- Research Report
- Construction Management Project
- Corporate Management & Finance

Employer commitments

All apprentices must have a contract of employment for the duration of their apprenticeship and they should be contracted to work a minimum of 30hrs per week including time spent in University and must be paid at or above the apprenticeship minimum wage.

Employers must provide evidence (employment contract & Job Description) that their apprentices' job role covers the approved occupation set out in the standard. In addition the apprentices' day-to-day work needs to encompass the core knowledge, skills and behaviours set out in the standard.

Employers will also need to ensure that they are in a position to support and mentor their apprentice through their studies to the gateway to their end-point assessment.

Entry requirements

- Construction Site Supervisor Level 4 Higher Apprenticeship
- Cognate Level 4 qualification in Construction and the Built Environment
- GCSE Maths and English A-C or Equivilant

Assessment

Assessment of the academic element of this apprenticeship will consist of closed book examination, or open book examination, seminar presentation, written essay, project work (group work and individual work) and research report.

End point assessment

The assessment plan for this standard has yet to be approved. We anticipate that the EPA will include professional registration with an appropriate professional body.

Cost

The cost will be to the funding cap which is expected to be £24,000 (TBC) which will be broken down as follows:

Levy Payers = £24,000, charged monthly via digital apprenticeship service

Non-Levy Payers = £2,400, (Government funds 90% the employer funds 10%).

Employers with less than 50 staff sending an apprentice aged 16-18 will have 100% of the training costs paid via the levy.

All employers that employ an apprentice aged 16-18 will receive a £1,000 incentive from government.
