Section 43 – trade secrets and prejudice to commercial interests	x	<p>We can confirm that we hold the information relating to the budget allocated for the student accommodation software. However, we cannot release this information as this could prejudice our commercial interests. LSBU is operating in an increasingly competitive environment with other Higher and Further Education Institutions. Disclosing this information could affect our contracting position if the information is shared with other suppliers in the market. This could give our competitors and potential private providers a level of insight that would be damaging to the long term strategic and financial success of LSBU.</p> <p>The section 43(2) exemption requires LSBU to apply the public interest test in considering whether to disclose the requested information. As a public body, LSBU has a duty of transparency, and we acknowledge that there is a level of public interest in University spending. However, as a provider of Higher and Further Education, we believe that there is a stronger public interest in the University maintaining its strategic and financial viability in a competitive environment, so we have decided to withhold this information.</p>
